Instructions for kit #4405790 4" diesel kit particulate trap-back kit 409 s/s

Fits: 2007-2008 full-size GM Duramax 3/4 & 1 ton w/6.6L LMM turbo diesel, 2wd & 4wd, crew cab models standard bed models only, 153" wheel base only. This kit will not fit other wheel base trucks.

Note: this is a particulate trap-back kit. Do not remove or modify your exhaust system in front of the 3-bolt flange after the particulate trap. Modifying or removing these parts is illegal, will void your GM warranty, and your vehicle will not run properly.

Note: check local laws on legality of this system. This system eliminates the muffler.

Note: Read these instructions fully and thoroughly before you begin.

1) To begin you need to remove the o.e. exhaust from the rear of the particulate trap, this is the section that has the 3-bolt flange at the rear of it. The easiest way is to remove the lower rear shock bolt from the rear axle. Safely raise up the frame and body from the rear axle, allowing the axle to hang lower than ride height. A frame contact shop hoist, or frame contact jack stands will do the trick. Do not use bumper jacks. Make sure you raise the vehicle on a flat, level surface, and verify that you have the vehicle supported properly.

2) Remove the 3 nuts from the flange at the rear of the particulate trap and front of the muffler. The o.e. muffler and tail pipe will now be able to be removed by snaking it out towards the front of the truck. Lower the truck to the original ride height, with the axle back to ride height.

3) Install the front extension pipe to the 3-bolt flange using an included gasket and the $\frac{1}{2}$ " hardware. It is the extension pipe with 2 bends in it, both ends have a 3-bolt flange on it. The outlet end is the end with the wire hanger nearest the flange. Install the wire hanger that is on the front extension pipe to the o.e. rubber hanger mount above.

4) Install the tail pipe to the front extension pipe using the included gasket and remaining $\frac{1}{2}$ " hardware.

7) Install the hanger on the tail pipe to the o.e. mount above.

8) Reinstall the bolt on the shock to the axle.

9) Tighten all bolts and check for clearance of the frame, body, spare tire, and brake and fuel lines.


